Policy 612, the Prison Rape Elimination Act follows the guidelines of the PREA standards. The previous PREA Coordinator worked diligently to address every standard. He recently retired and his replacement has only been on the job for a few months and is still finding his way. As a sergeant within the command structure, his position gives him the authority to develop and oversee the efforts of the facility to prevent, detect, and respond to sexual abuse and sexual harassment. With the current correctional officer shortage, he and the Chief Corrections Deputy are filling in shifts. Once this situation is resolved, they are confident that jointly they can ensure the time is available to meet all the standards.</p> <p data-bbox="231 515 1508 705">CORRECTIVE ACTION: The auditor monitored progress through the corrective action period to ensure the PREA Coordinator has enough time to complete all responsibilities in maintaining compliance with the PREA standards. Although they had major challenges with very low staffing levels throughout the corrective action period, the PREA Coordinator and the Chief Corrections Deputy were able to complete the required corrective actions and give the attention needed to their PREA responsibilities.</p>

	<p data-bbox="242 210 451 237">Auditor Discussion</p> <p data-bbox="242 271 1481 566">The auditor reviewed the Richland County Jail policy, the organization structure, verified the staffing levels through the schedule that was provided and verified through direct observation while on the facility tour. The Richland County Jail has recently experienced heavy turnover with the top two positions retiring within the last six months. In addition, they currently have five (5) vacant corrections officer positions, and one corrections officer is on extended family leave. The facility staffing plan requires ten (10) total positions – the two administrators (the Chief Corrections Officer and the Sergeant) and eight corrections officers. They are filling shifts by utilizing the two administrators in corrections officer positions, a deputy from the Sheriff’s office who completes some rounds when needed and three part-time staff who are able to work an occasional shift. There were three female corrections officers at the time of the on-site audit and there were two female inmates within the facility.</p> <p data-bbox="242 598 1485 992">The Richland County Jail is a small, 33-bed facility. There are two managers and eight line staff. They require at a minimum staffing level of one male and one female officer on duty. In reviewing the schedule almost every day for the past 28-day schedule the overnight shift was posted by a single male officer. During these times if a female offender is brought in, either a female deputy or a female corrections officer is called in to perform the pat search and supervise the change-out. The auditor confirmed this practice and all interviews with inmates and staff confirmed the practice of a female staff always performing the pat search. The management staff stated they come in frequently to conduct unannounced rounds to observe operations, and this was verified by line staff. The auditor viewed the electronic jail log to confirm examples of this type of entry. The Jail Administrator pulled the word “Supervisory” in the log and sent the auditor a snip of these entries. The administrators are able to conduct unannounced rounds without alerting the staff on duty. Their policy prohibits staff from alerting other staff members that these supervisory rounds are occurring. There are multiple cameras throughout the facility that are monitored both in the control room and the law enforcement dispatch center. The agency has not completed an annual assessment as required by § 115.11, to assess, determine, and document whether adjustments are needed.</p> <p data-bbox="242 1021 1437 1115">CORRECTIVE ACTION: The auditor required documented evidence of an annual assessment of the staffing plan to determine whether adjustments are needed to the management of the jail in relation to staffing levels, assignments, and monitoring technology. The Chief Corrections Deputy provided the annual staffing plan review.</p>

There are female staff on duty to conduct searches of new female admissions in booking. If a female staff is not scheduled, a patrol deputy or an off-duty corrections officer is called in to fill that role. All interviews with both inmates and staff confirmed this practice. The facility prohibits examination for the sole purpose of determining gender and staff are knowledgeable of correct search procedures for inmates who are transgender or intersex. If the offender's genital status is unknown, it is determined during conversations with the offender, by reviewing medical records, or, if necessary, by learning that information as part of a broader medical examination conducted in private by a medical practitioner. Staff are trained in cross-gender searches. The facility does not conduct cross gender strip or pat down searches, but policy requires that if this to occur to document it with justification. There have not been any of these types of searches of offenders and this was verified by interviews with inmates. The facility has policies and procedures and physical construction of housing areas that enable offenders to shower, perform bodily functions, and change clothing without nonmedical staff of the opposite gender viewing them in a state of undress. The auditor does recommend that a camera be placed to view the officer only during the change out process during intake as this process requires a staff member to be in a one-on-one situation with an inmate while the inmate is in a state of undress.</p> <p data-bbox="229 725 1509 904">Policies and procedures require staff of the opposite gender to announce their presence when entering an offender housing unit. Inmates shower in private shower stalls with shower curtains to provide privacy and to prevent observation by staff of the opposite gender or casual observers. Based on staff interviews, inmate interviews and direct observation by the auditor, all staff members of the opposing gender consistently announce their presence when entering units where the probability exists that the inmate may be showering, changing clothes or toileting.</p>

	<p>The Richland County Jail implemented a measure for use of an interpretive service, the Language Line, during the last audit in 2018. During the on-site portion of the audit there were no inmates who needed assistance. The staff assist visually impaired or those with intellectually impairments by verbally going over the material or providing assistance in a manner they are able to comprehend.</p>

The auditor was provided criminal background checks that they re-ran. However, during this audit they again were not able to provide the auditor documentation of staff criminal background checks.</p> <p data-bbox="240 465 1426 524">The facility had within employment files a form documenting the check with previous institutional employers specifically regarding substantiated allegations of sexual abuse.</p> <p data-bbox="240 557 1490 714">During the last audit corrective action period the Richland County Jail changed their hiring process by requiring prospective new hires to complete a form that asked questions of prospective new hires regarding any previous sexual misconduct including acknowledging that they have a continuing duty to report. However, during this audit they were unable to locate any of those forms that were maintained by the previous jail administrators. In addition, those forms are not being completed during the annual employee evaluation process.</p> <p data-bbox="240 748 1490 972">CORRECTIVE ACTION: To comply with this standard the auditor required that the facility provide criminal background check documentation for all employees and contractors and that these criminal background checks have been completed within the last five years. In addition, the auditor required documentation of asking the prospective employee questions during the hiring process regarding previous sexual misconduct, the acknowledgement forms of employees continuing duty to report any sexual misconduct within the jail or within the community and the forms that have been completed during the employee's annual employee evaluation. The Richland County Jail provided updated background checks, their hiring process and updated acknowledgement forms regarding sexual misconduct and a continuing duty to report.</p>

	<p data-bbox="231 197 1508 257">Auditor Discussion</p> <p data-bbox="231 257 1508 616">The auditor reviewed the PREA policy, interviewed the nurse, the investigator from the sheriff's office assigned to conduct criminal investigations, the nursing supervisor for the emergency room at the local hospital and the PREA Coordinator. Victims of sexual abuse have access to forensic medical exams through St. Francis Hospital in Breckinridge MN. The auditor spoke with the hospital, and she confirmed a SANE trained nurse will provide forensic sexual assault medical examinations. If there is no SANE nurse available a referral will be made to Sanford Hospital in Fargo, or the forensic exam will be completed through telemedicine by a SANE nurse with the emergency room nurse aiding or, as a last resort they will complete the forensic examination utilizing the forensic sexual assault collection kit which contains explicit instructions. The facility has an MOU with Three Rivers Crisis Center for advocacy services. Currently the investigator for the Sheriff's office will handle all investigations until either the Jail Administrator or the PREA Coordinator complete the required specialized training for investigators in confinement. Once that is complete administrative allegations of sexual misconduct within the jail will be investigated by their administrative investigator. Criminal investigations involving inmate-on-inmate sexual misconduct are investigated by the investigator with the Richland County Sheriff's office who has completed various sexual assault investigative trainings over the course of his career as well as the North Dakota Department of Corrections and Rehabilitation course PREA Investigator training. Within 30 days of arrival the inmates are shown a video in the housing area with more comprehensive information. However, it appears this has lapsed over the past couple of months. There is also information in a pamphlet, within the inmate handbook and on posters located throughout the facility.</p> <p data-bbox="229 456 1509 604">CORRECTIVE ACTION: The auditor required that the facility get back on track with showing the video to inmates that has the more comprehensive information. 	<p data-bbox="229 192 1509 255">Auditor Discussion</p> <p data-bbox="229 255 1509 658">The previous PREA Coordinator for the Richland County Jail received specialized training as a facility investigator to conduct administrative investigations. The current PREA Coordinator or the Chief Corrections Officer have not completed this course. Currently the investigator from the Richland County Sheriff's office is responsible for administrative investigations until someone within the jail completes specialized training for investigators. All inmate-on-inmate criminal allegations are turned over to the Richland County Sheriff's Office for investigation. The auditor interviewed the criminal investigator and found him to be well experienced with superb skills in addressing criminal sexual abuse investigations for the Richland County Jail. He completed the North Dakota Department of Corrections and Rehabilitation course PREA Investigator Training. He stated his specialized training includes techniques for interviewing sexual abuse victims, proper use of Miranda and Garrity warnings, sexual abuse evidence collection in confinement settings, and the criteria and evidence required to substantiate a case for administrative action or prosecution referral.
