

## NOTICE OF PRIMARY ELECTION TUESDAY, JUNE 9, 2026

Notice is hereby given that on Tuesday, the 9th day of June, 2026, in the County of Richland, State of North Dakota, an election will be held for the election of state, district, county and city officers, state and local measures.

This election will be held with seven (7) Vote Centers along with the option of absentee voting.

Valid Richland County residents interested in obtaining an absentee ballot may visit the ND Secretary of State's website: [sos.nd.gov/elections](https://sos.nd.gov/elections) to print an Absentee Ballot Application or call the Richland County Auditor at 701-642-7700 to have an application sent to them. After printing, complete/sign and return to the Richland County Auditor, 418 2nd Ave N, Wahpeton ND 58075. Completed/signed applications may also be emailed to [sfossum@co.richland.nd.us](mailto:sfossum@co.richland.nd.us)

Once Richland County receives the application, verifies the information is correct and it is signed, a ballot will be mailed to the voter.

You can return your completed vote by mail ballot by methods below:

1. USPS mail - Richland County Auditor, 418 2nd Ave N, Wahpeton ND 58075
2. Deposit in Secure Ballot Drop Box before 7:00 pm on Tuesday June 9, 2026, located at the following location:  
Richland County Courthouse, 418 2<sup>nd</sup> Ave N, Wahpeton ND – NW corner of Courthouse

\*Absentee ballots must be received by the close of polls (7:00 pm) on Tuesday, June 9th, 2026 regardless of the date they were postmarked by USPS. Ballots may be mailed, hand delivered to the Auditor's Office, or deposited in the Secure Drop Box located on the NW corner of the Courthouse. Absentee ballots may NOT be accepted at any of the seven vote centers. County residents also have the option to vote in person, via an absentee ballot, Monday - Friday from 8:00 am - 5:00 pm at the Auditor's Office located in the Courthouse. The last day to request an absentee ballot application for the Primary Election is Monday, June 8, 2026.
