Call to Order – Laurie Straus, Chair

Introductions

Kayla introduced Kaci and Susie. Commissioner Ehlert was also introduced.

Review/Approval of Minutes & Agenda - Laurie called meeting to order

Patty made a motion to approve the minutes and agenda 2nd by Lance, motion carried.

Health Department Overview

Amanda gave an update on Jail, FP, TB, and footcare

- Jail -
 - Request was made for ear wax removal and stool softener to be added to standing orders. Nyarandi agreed to having these added to the standing orders.
 - Amanda discussed adding opioid and alcohol withdrawal standing orders
 - Dr. Nyarandi signed the standing orders and requested that orders be faxed to the pharmacy.
- Family Planning
 - Amanda would like to implement STI testing with the jail physicals.
 - There is a grant available for syphilis testing. We would get 500 tests
 - The Board of Health supports continuing with grant.
- TB
 - Currently working to treat TB cases in the community.
- Footcare
 - Numbers have increased. Rural clinics were added and RCHD has added extra days in town
- WIC/Car Seats/Cribs for Kids
 - Danielle gave update, programs are going well.
- Baby Café

 RCHD is having a hard time getting this program going, will continue to work on under grant funding.

PFS

- New grant approximately \$130k/yr for 4 yrs
- We are working with the state through the planning stages of this grant and have not started the implementation stage yet.
- Tobacco
 - We are orientating new staff to this grant.
- CRC
 - Open enrollment 415 visits, 432 clients
 - This year clients who visited the health department saved an average of \$700 per person
- Home Health
 - 4 new admits this last quarter, 8 discharges
 - o Audit from med sets has been complete
 - o License was renewed, no deficiencies were found during survey
- Staffing
 - We currently have 2 staff out on extended leave, we have shifted duties to cover, and we are stretched extremely thin right now.
- RCHD was nominated for the Annual Business Award from Wahpeton/Breck Chamber.
- Discussion on chain of command within the county. Richland County Health Department Administrator reports to the Board of Health and the Board of Health acts as the Administrator's direct supervisor.
- Annual Year End Budget
 - Kayla reviewed budget
 - County dollars support approximately 16% of the RCHD budget.
- Discussion on Richland County Health Department moving to a District. The Board of Health supported moving forward.
- Growth and Development classes will be done this spring. This program is offered to all Richland County School Districts.
- Major updates on the treatment room are on hold until a decision is made on the jail.
