RICHLAND COUNTY BOARD OF COMMISSIONERS JANUARY 4, 2022

The Richland County Board of Commissioners met on January 4, 2022 at the Richland County Courthouse with Commissioners Sid Berg, Nathan Berseth, Tim Campbell, Rollie Ehlert and Perry Miller. Others in attendance were Administration Personnel Fossum and DelVal; Assistant State's Attorney Moen; and a Daily News Reporter. Visitor Rich Slagle attended a portion of the meeting.

A motion was made by Campbell and seconded by Miller to <u>approve the</u> Agenda as amended. Vote was unanimous.

A motion was made by Campbell and seconded by Berg to <u>approve the Minutes of meetings December 7 and December 21</u>. Vote was unanimous.

- B) Buildings & Grounds The estimate for the HVAC System came in considerably higher than expected at \$2.9 million. A Courthouse Facilities grant has been submitted.
- C) Public Health Still working on the Director of Nursing Position but waiting for the Eide Bailly study. The new pickup has arrived.
- D) JDA -A meeting was held last month- three loans were approved. The next meeting will be held in Lidgerwood.

HIGHWAY DEPARTMENT

Highway Personnel in attendance were Engineer Sedler and Ron Hohenstern.

Sedler presented paperwork for signatures for the following:

- CR1 Railroad Improvements \$12,859

Equipment Operator - One application was received for the vacant position.

<u>Bid Opening</u> - Will have a bid opening at the February 1 meeting for a Motor Grader.

- G) Park Board The next meeting is scheduled for March.
- H) Administration Fossum reported the following:
 - reminded the Commission they wanted to meet with the Water Board quarterly, she is waiting to hear back on their meeting dates/agendas.
 - the City of Wahpeton has approved the 2022 911/Communications Contract, we are waiting on the signatures.

- still waiting to hear from Eide Bailly on when they will be providing our Efficiency Study.
- would like to request a Market Survey for Salaries from Gallagher so we have information for budgeting, this should be done every 3-4 years. The proposed cost is \$20,000.
- Year End Budget adjustments and transfers were presented. The general fund came in approximately \$600,000 under budget and larger state aid disbursements came in than anticipated. With the transfers as presented, we will be able to build the new Highway Shop without having to take out financing.

A motion was made by Berg and seconded by Miller to approve the Year-end Transfers as presented. Vote was unanimous.

A motion was made by Ehlert and seconded by Miller to <u>approve the Year-end Budget Adjustments as presented</u>. Vote was unanimous.

The Board discussed the <u>ARPA Funds</u> Bonuses paid to state employees which created an issue to other Departments.

MELISSA NEITZKE and SHERIFF LESHOVSKY - JAIL

Neitzke and Leshovsky were present to answer questions that came up at a previous Commission meeting regarding the Jail, which included the following:

<u>Ransom County Contract</u> - Leshovsky reported negotiations with Ransom County for housing inmates is still ongoing - we have provided them a contract and are waiting on them.

<u>Jail Capacity</u> - There is bed space for 30 however the current limit is 19. We have to keep sentenced, un-sentenced, females, etc all in separate spaces. We keep our limit to 16, leaving space for Domestic Violence.

With covid protocols this is a moving target on a daily basis per Public Health Guidelines. The Health Department would like a Policy on when Jailers can test inmates.

Testing inmates for illness, pregnancy, Covid etc. has to do with Health Department Liability and the CLIA waiver and because we have no policy on binex, Jailers cannot test inmates.

Berseth recommended the State's Attorney Office look into the CLIA waiver/Policy. Sheriff Leshovsky stated he would address it with the Health Department.

<u>Staffing</u> - One more female jailer is needed and they will be fully staffed.

<u>Contract Fees</u> - Rates for federal inmates has not been changed for several years and should be reviewed.

The Commission requested Neitzke and Leshovsky come back to the February meeting with an update on the "Policy" and some "Contract Fee" suggestions.

A motion was made by Campbell and seconded by Ehlert to <u>approve the Sale</u> of County property in Fairmount to the City of Fairmount. Vote was unanimous.

A motion was made by Ehlert and seconded by Campbell to approve the payment of bills. Vote was unanimous.
