The Richland County Board of Commissioners met on October 6, 2022 at the Richland County Courthouse with Commissioners Sid Berg, Nathan Berseth, Tim Campbell, Rollie Ehlert and Perry Miller. Sedler reported 92 Harvest Permits have been sold to date.

Sedler reported the Road Foreman Position is closed for now, the position is still vacant. Sedler requested adding an Assistant Foreman position, he is working with HR on this position which will be submitted to Gallagher for classification.

Berg reported receiving requests for speed limit signage at Christine. Sedler reported he was also contacted. The Board recommended Sedler check into the cost for lighted Speed Signs for that area.

- A) Social Services The vacant position has been filled and three more additional employees have been hired, they will be assisting with Cass County.
- B) Buildings & Grounds A dedication for the new monument will be held next spring.

Berseth suggested that those communities with issues contract with the County at the District Level to take individuals to Court.
