115.11 Zero tolerance of sexual abuse and sexual harassment; PREA coordinator Auditor Overall Determination: Meets Standard **Auditor Discussion** The Richland County Jail has a very thorough policy. Policy 612, the Prison Rape Elimination Act follows the guidelines of the PREA standards. The previous PREA Coordinator worked diligently to address every standard. He recently retired and his replacement has only been on the job for a few months and is still finding his way. As a sergeant within the command structure, his position gives him the authority to develop and oversee the efforts of the facility to prevent, detect, and respond to sexual abuse and sexual harassment. With the current correctional officer shortage, he and the Chief Corrections Deputy are filling in shifts. Once this situation is resolved, they are confident that jointly they can ensure the time is available to meet all the standards. CORRECTIVE ACTION: The auditor monitored progress through the corrective action period to ensure the PREA Coordinator has enough time to complete all responsibilities in maintaining compliance with the PREA standards. Although they had major challenges with very low staffing levels throughout the corrective action period, the PREA Coordinator and the Chief Corrections Deputy were able to complete the required corrective actions and give the attention needed to their PREA responsibilities.

115.13 Supervision and monitoring

Auditor Overall Determination: Meets Standard

Auditor Discussion

The auditor reviewed the Richland County Jail policy, the organization structure, verified the staffing levels through the schedule that was provided and verified through direct observation while on the facility tour. The Richland County Jail has recently experienced heavy turnover with the top two positions retiring within the last six months. In addition, they currently have five (5) vacant corrections officer positions, and one corrections officer is on extended family leave. The facility staffing plan requires ten (10) total positions – the two administrators (the Chief Corrections Officer and the Sergeant) and eight corrections officers. They are filling shifts by utilizing the two administrators in corrections officer positions, a deputy from the Sheriff's office who completes some rounds when needed and three part-time staff who are able to work an occasional shift. There were three female corrections officers at the time of the on-site audit and there were two female inmates within the facility.

The Richland County Jail is a small, 33-bed facility. There are two managers and eight line staff. They require at a minimum staffing level of one male and one female officer on duty. In reviewing the schedule almost every day for the past 28-day schedule the overnight shift was posted by a single male officer. During these times if a female offender is brought in, either a female deputy or a female corrections officer is called in to perform the pat search and supervise the change-out. The auditor confirmed this practice and all interviews with inmates and staff confirmed the practice of a female staff always performing the pat search. The management staff stated they come in frequently to conduct unannounced rounds to observe operations, and this was verified by line staff. The auditor viewed the electronic jail log to confirm examples of this type of entry. The Jail Administrator pulled the word "Supervisory" in the log and sent the auditor a snip of these entries. The administrators are able to conduct unannounced rounds without alerting the staff on duty. Their policy prohibits staff from alerting other staff members that these supervisory rounds are occurring. There are multiple cameras throughout the facility that are monitored both in the control room and the law enforcement dispatch center. The agency has not completed an annual assessment as required by § 115.11, to assess, determine, and document whether adjustments are needed.

CORRECTIVE ACTION: The auditor required documented evidence of an annual assessment of the staffing plan to determine whether adjustments are needed to the management of the jail in relation to staffing levels, assignments, and monitoring technology. The Chief Corrections Deputy provided the annual staffing plan review.

115.14	Youthful inmates

Limits to cross-gender viewing and searches Auditor Overall Determination: Meets Standard Auditor Discussion The Richland County Jail prohibits cross gender searches of inmates. There are female staff on duty to conduct searches of

The Richland County Jail prohibits cross gender searches of inmates. There are female staff on duty to conduct searches of new female admissions in booking. If a female staff is not scheduled, a patrol deputy or an off-duty corrections officer is called in to fill that role. All interviews with both inmates and staff confirmed this practice. The facility prohibits examination for the sole purpose of determining gender and staff are knowledgeable of correct search procedures for inmates who are transgender or intersex. If the offender's genital status is unknown, it is determined during conversations with the offender, by reviewing medical records, or, if necessary, by learning that information as part of a broader medical examination conducted in private by a medical practitioner. Staff are trained in cross-gender searches. The facility does not conduct cross gender strip or pat down searches, but policy requires that if this to occur to document it with justification. There have not been any of these types of searches of offenders and this was verified by interviews with inmates. The facility has policies and procedures and physical construction of housing areas that enable offenders to shower, perform bodily functions, and change clothing without nonmedical staff of the opposite gender viewing them in a state of undress. The auditor does recommend that a camera be placed to view the officer only during the change out process during intake as this process requires a staff member to be in a one-on-one situation with an inmate while the inmate is in a state of undress.

Policies and procedures require staff of the opposite gender to announce their presence when entering an offender housing unit. Inmates shower in private shower stalls with shower curtains to provide privacy and to prevent observation by staff of the opposite gender or casual observers. Based on staff interviews, inmate interviews and direct observation by the auditor, all staff members of the opposing gender consistently announce their presence when entering units where the probability exists that the inmate may be showering, changing clothes or toileting.

115.16	Inmates with disabilities and inmates who are limited English proficient
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The Richland County Jail implemented a measure for use of an interpretive service, the Language Line, during the last audit in 2018. The Language Line service provides the jail a method of assisting inmates who are deaf and inmates who are limited English proficient. During the interviews all staff were able to state their methods for assisting inmates with disabilities and who are limited English proficient. During the on-site portion of the audit there were no inmates who needed assistance. The staff assist visually impaired or those with intellectually impairments by verbally going over the material or providing assistance in a manner they are able to comprehend.

115.17 Hiring and promotion decisions

Auditor Overall Determination: Meets Standard

Auditor Discussion

During the last audit the administration stated they perform background checks, only hire those with acceptable backgrounds, but discard them after they are reviewed – only retaining the letter from the Attorney General's office on the outcome of the law enforcement criminal background check. The auditor was provided criminal background checks that they re-ran. However, during this audit they again were not able to provide the auditor documentation of staff criminal background checks.

The facility had within employment files a form documenting the check with previous institutional employers specifically regarding substantiated allegations of sexual abuse.

During the last audit corrective action period the Richland County Jail changed their hiring process by requiring prospective new hires to complete a form that asked questions of prospective new hires regarding any previous sexual misconduct including acknowledging that they have a continuing duty to report. However, during this audit they were unable to locate any of those forms that were maintained by the previous jail administrators. In addition, those forms are not being completed during the annual employee evaluation process.

CORRECTIVE ACTION: To comply with this standard the auditor required that the facility provide criminal background check documentation for all employees and contractors and that these criminal background checks have been completed within the last five years. In addition, the auditor required documentation of asking the prospective employee questions during the hiring process regarding previous sexual misconduct, the acknowledgement forms of employees continuing duty to report any sexual misconduct within the jail or within the community and the forms that have been completed during the employee's annual employee evaluation. The Richland County Jail provided updated background checks, their hiring process and updated acknowledgement forms regarding sexual misconduct and a continuing duty to report.

115.18	Upgrades to facilities and technologies
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The auditor reviewed the Richland County Jail policy, video monitoring systems, directly observed all areas of the facility and conducted interviews with the Jail Administration. The facility considers protection of inmates and the standards when contemplating upgrades to the facility or in the application of technology. Best practice is to alleviate any area where an inmate can be in a one-on-one situation with another inmate or with a staff member. The auditor identified the strip search area is an area of concern. The auditor recommends a camera that is able to view the officer conducting a search, but not the inmate

115.21	Evidence protocol and forensic medical examinations

	Auditor Discussion
	The auditor reviewed the PREA policy, interviewed the nurse, the investigator from the sheriff's office assigned to conduct criminal investigations, the nursing supervisor for the emergency room at the local hospital and the PREA Coordinator. Victims of sexual abuse have access to forensic medical exams through St. Francis Hospital in Breckinridge MN. The auditor spoke with the hospital, and she confirmed a SANE trained nurse will provide forensic sexual assault medical examinations. If there is no SANE nurse available a referral will be made to Sanford Hospital in Fargo, or the forensic exam will be completed through telemedicine by a SANE nurse with the emergency room nurse aiding or, as a last resort they will complete the forensic examination utilizing the forensic sexual assault collection kit which contains explicit instructions. The facility has an MOU with Three Rivers Crisis Center for advocacy services. If law enforcement responds to a sexual assault case within the jail, evidence protocol is followed, and they work cooperatively with the SANE nurse to ensure all usable physical evidence is gathered.

115.22	Policies to ensure referrals of allegations for investigations
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The facility refers all allegations for investigation. The Richland County Jail investigations are completed by qualified investigators and required documentation and reporting will occur. Currently the investigator for the Sheriff's office will handle all investigations until either the Jail Administrator or the PREA Coordinator complete the required specialized training for investigators in confinement. Once that is complete administrative allegations of sexual misconduct within the jail will be investigated by their administrative investigator. Criminal investigations involving inmate-on-inmate sexual misconduct are investigated by the investigator with the Richland County Sheriff's office who has completed various sexual assault investigative trainings over the course of his career as well as the North Dakota Department of Corrections and Rehabilitation course PREA Investigator training. Criminal investigations involving staff-on-inmate sexual misconduct are investigated by an investigator from the North Dakota Bureau of Investigations. This requirement for an independent
	investigation conducted by the Bureau of Criminal Investigation (BCI) is outlined in policy 400.3.2 INDEPENDENT INVESTIGATIONS.

115.31	Employee training
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The auditor interviewed the Jail Administrator, the PREA Coordinator and staff. The jail has completed PREA training for all staff. Basic PREA training with staff was apparent during the interviews as staff were knowledgeable in the required competencies such as the correct first responder response – separate, provide care, protect evidence, call for assistance, notify shift supervisor and provide a written report. The staff have signed a statement acknowledging that they understand and will comply with all requirements as presented during their training and specifies requirements lettered (1) through (10) the same as in this standard.

115.32	Volunteer and contractor training

	Auditor Discussion
	The auditor interviewed the PREA Coordinator, the religious volunteer and the county health nurse. All county health nurses, religious volunteers, AA and NA volunteers have completed training. The chaplain stated that when meeting with an inmate he points to the PREA poster on the wall and tells the inmate that he is bound by PREA and that even though he is a chaplain, he has to report anything related to PREA. The only other contractor that comes into the jail is the county maintenance worker and he is always escorted by the jail staff. The auditor reviewed the policy and reviewed the training outlines. The volunteers and contractors have the required training and background checks.

115.33	Inmate education
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The Richland County Jail has implemented an inmate training program. The basic information is provided to an inmate during the intake process about the jail's zero tolerance policy and how to report. The inmate's sign acknowledgment that they have received this training and the documentation was provided to the auditor. Within 30 days of arrival the inmates are shown a video in the housing area with more comprehensive information. However, it appears this has lapsed over the past couple of months. There is also information in a pamphlet, within the inmate handbook and on posters located throughout the facility.
	CORRECTIVE ACTION: The auditor required that the facility get back on track with showing the video to inmates that has the more comprehensive information. The auditor required signature sheets for all inmates that have viewed the video during times requested by the auditor during the corrective action period. The Richland County Jail provided the necessary documentation to verify reimplementation of the inmate education by video.

115.34 Specialized training: Investigations Auditor Overall Determination: Meets Standard **Auditor Discussion** The previous PREA Coordinator for the Richland County Jail received specialized training as a facility investigator to conduct administrative investigations. The current PREA Coordinator or the Chief Corrections Officer have not completed this course. Currently the investigator from the Richland County Sheriff's office is responsible for administrative investigations until someone within the jail completes specialized training for investigators. All inmate-on-inmate criminal allegations are turned over to the Richland County Sheriff's Office for investigation. The auditor interviewed the criminal investigator and found him to be well experienced with superb skills in addressing criminal sexual abuse investigations for the Richland County Jail. He completed the North Dakota Department of Corrections and Rehabilitation course PREA Investigator Training. He stated his specialized training includes techniques for interviewing sexual abuse victims, proper use of Miranda and Garrity warnings, sexual abuse evidence collection in confinement settings, and the criteria and evidence required to substantiate a case for administrative action or prosecution referral. Allegations of staff sexual misconduct are referred to the North Dakota Bureau of Investigations CORRECTIVE ACTION: The auditor required that someone within the jail complete the administrative investigation training and provide the auditor documentation of this training. The auditor recommends they complete the National Institute of Corrections course PREA: Investigating Sexual Abuse in a Confinement Setting as soon as possible. If the North Dakota Department of Corrections and Rehabilitation offer another investigation course at a later date, the auditor recommends that they attend this training as it is more comprehensive. The PREA Coordinator completed the National Institute of Corrections

course PREA: Investigating Sexual Abuse in a Confinement Setting in January.

115.35	Specialized training: Medical and mental health care
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The Richland County Jail does not have any full or part time nursing staff, but rather contracts with the county health office for those services. The facility was not able to provide the training documents at the time of the on-site audit, but located them during the corrective action period. The nurse completed the National Institution of Corrections courses <i>PREA 201 for Medical and Mental Health Practitioners</i> in 2018.

Auditor Overall Determination: Meets Standard Auditor Discussion The Richland County Jail completes a screening process upon intake. During this process the correctional staff completes the medical screening form. PREA screening questions are a part of this form. However, because the form is a part of the medical screening, there is no way to break the PREA screening questions out and objectively determine propensity to sexual victimization or abusiveness. There is no numerical value assigned to questions to determine when a person should be screened as to having the potential to victimization or perpetration of sexual abuse. An objective screening typically has a numerical value assigned to certain factors so that the same determination can be made regardless of who completes the screening. Also, the auditor was not provided any documented evidence of a formal follow-up screening of inmates within 30 days following an inmate's arrival. Staff confirmed that they are continually reassessing an inmate's status. They specifically would reassess if a referral or request was made by any staff, volunteer or contractor or if there was an incident of sexual abuse or receipt of additional information that has bearing on their risk of sexual victimization or abusiveness.

CORRECTIVE ACTION: The auditor required a change to the screening process completed at intake to ensure that the screening is objective. The auditor required rescreening documentation within the corrective action period. The Richland County Jail modified their screening form to be more objective and provided screenings and rescreening documents during periods of the corrective action period.

115.42	Use of screening information
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	Richland County Jail has a PREA screening process and uses that along with other classification methods to determine placement within their housing unit, bed assignment, work assignment or programming. All housing assignments, including housing for inmates who are transgender are done on a case-by-case basis considering the inmate's own views of safety. All inmates shower separately from other offenders. The Richland County Jail implements appropriate controls on the dissemination of responses to screening questions asked pursuant to this standard in order to ensure that sensitive information is not exploited to the offender's harm by staff or other offenders. During the interviews staff were knowledgeable of this PREA standard.

115.43	Protective Custody
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	Richland County Jail staff typically finds alternative housing units that provide protection for the inmate without segregating or isolating them. If they use protective custody, it is for very limited duration and only until they can find appropriate housing. Even then for Richland County Jail protective custody is not isolation. They still participate in recreation and have out of cell time like everyone else. Offenders placed in segregated housing for this purpose have access to programs, privileges, education, and work opportunities. If the Richland County Jail restricts access to programs, privileges, education, or work opportunities, they will document the opportunities that have been limited, the duration of the limitation, and the reasons for such limitations. Offenders at high risk for sexual victimization would not be placed in involuntary segregated housing unless an assessment of all available alternatives has been made, and a determination has been made that there is no available alternative means of separation from likely abusers.

115.51 Inmate reporting

Auditor Overall Determination: Meets Standard

Auditor Discussion

The auditor interviewed administrators, staff, and inmates, reviewed policy and toured the facility. The Richland County Jail provides multiple internal ways for inmates to privately report sexual abuse and sexual harassment, retaliation by other offenders or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents. Staff accepts reports made verbally, in writing, anonymously, and from third parties and promptly document any verbal reports.

At the time of the on-site portion of the audit the Richland County Jail was utilizing both the Three River's Crisis Center and the Wahpeton Police Department for external reporting. The auditor informed the facility that the Department of Justice legal interpretation of this standard through a FAQ posted on the PREA Resource Center website dated 6Feb2020 states that typically a rape crisis center and other victim service providers should not be used for this purpose. They have a mission of providing support and services to victims. Under federal law, if such centers and providers are funded at least in part, either as a direct recipient or as a subrecipient of certain federal grants they are required to keep identifying information about victims confidential. The only limited exceptions to this requirement are when the victim signs an informed, written, time-limited release, or when release is required by a legal mandate. This requirement to keep confidential identifying information about victim's conflicts with the requirement of PREA Standard 51(b) to be able to immediately forward reports of sexual abuse and sexual harassment to agency officials. The auditor discussed removing Three River's Crisis Center as a reporting entity from all posters, handbooks and training provided to inmates. The Richland County Jail needs to ensure that the number to the Wahpeton Police Department does not require an inmate PIN to call and that the calls is not recorded so that the anonymity of the inmate is maintained if requested.

The Richland County Jail has posted notices for persons detained solely for civil immigration purposes on contacting their consular service. This notice is posted both in English and Spanish.

CORRECTIVE ACTION: The auditor required that only the Wahpeton Police Department be listed as the method for inmates to report sexual abuse and sexual harassment to an external entity. The auditor required a Memorandum of Understanding with the Wahpeton Police Department to ensure that they agree to receive calls from inmates at the Richland County Jail, will immediately forward any reports of sexual abuse or sexual harassment to the Richland County Jail administrator or PREA Coordinator and allow the inmate to remain anonymous upon request. The auditor required copies of updated educational materials to reflect that that the Wahpeton Police Department is the only external reporting entity and that they Three Rivers Crisis Center is only listed as an advocacy service for emotional support services. Educational materials include inmate training, the inmate handbook, posters, and the kiosk. The Richland County Jail provided their documentation including the updated MOUs with the Wahpeton Police Department and the Three Rivers Crisis Center.

115.52 **Exhaustion of administrative remedies** Auditor Overall Determination: Meets Standard **Auditor Discussion** The auditor reviewed policy 612 Prison Rape Elimination Act, policy 620 Inmate Grievances, conducted staff and inmate interviews. The Richland County Jail does not impose a time limit on when an offender may submit a grievance regarding an allegation of sexual abuse. They do not require an offender to use any informal grievance process, or to otherwise attempt to resolve with staff, an alleged incident of sexual abuse. They ensure that an offender who alleges sexual abuse may submit a grievance without submitting it to a staff member who is the subject of the complaint, and such grievance is not referred to a staff member who is the subject of the complaint. They issue a final decision on the merits of any portion of a grievance alleging sexual abuse within 90 days of the initial filing of the grievance. Third parties, including fellow offenders, staff members, family members, attorneys, and outside advocates, are permitted to assist offenders in filing requests for grievances relating to allegations of sexual abuse, and are also be permitted to file such requests on behalf of offenders. They have established procedures for the filing of an emergency grievance when the offender is subject to a substantial risk of imminent sexual abuse. After receiving an emergency grievance alleging a substantial risk of imminent sexual abuse, the Richland County Jail immediately forwards the grievance (or any portion thereof that alleges the substantial risk of imminent sexual abuse) to a level of review at which immediate corrective action is taken, and provides an initial response within 48 hours, and issues a final decision within 5 calendar days. The initial response and final decision documents their determination whether the offender is in substantial risk of imminent sexual abuse and the action taken in response to the emergency grievance. The Richland County Jail may discipline an offender for filing a grievance related to alleged sexual abuse only where the Richland County Jail demonstrates that the offender filed the grievance in bad faith. Offenders are encouraged to report directly to staff members, but that if they do not feel comfortable in doing this, they may report to their

external reporting entity. An inmate does not have to exhaust one method of reporting before being allowed to employ another method in order to obtain action. Section 620.6 of the Grievance Policy provides additional provisions for grievances

related to sexual abuse.

	Inmates have access to outside confidential support services. The facility has an agreement with the Three Rivers Crisis Center for advocacy and emotional support services. In addition, the nurse may make referrals for mental health support services if they feel that is warranted.
	CORRECTIVE ACTION: The auditor required documentation that the Richland County Jail has notified Three Rivers Crisis Center that they will no longer be listed as an external reporting entity but only as an advocacy and emotional support service. Staff interviews and interviews with the PREA Coordinator indicate that staff are aware of their responsibilities to coordinate responses within the facility. Measures include housing changes, removing contact of alleged staff/inmate abusers and emotional support services for those who fear retaliation. 	The auditor interviewed staff and inmates, administration and the criminal investigator. There were no documented investigations at the Richland County Jail to review. Through the interview with the investigator it was determined that investigations are not terminated should the source of the allegation recant. Should criminal prosecution be considered, the investigator coordinates with the state's attorney. Polygraph tests are not used in the course of their investigations. All written reports are retained for as long as the alleged abuser is incarcerated or employed by the facility plus five years. Investigations will not be terminated due to the departure of an alleged abuser or victim. These steps are properly documented in the PREA policy. At the time of the time of the on-site audit the investigator with the Richland County Sheriff's Department was responsible for administrative investigations until either the administrator or the PREA Coordinator can complete specialized training. Investigations include efforts to determine whether staff actions/failures contributed to the abuse documented through written reports, which will include physical/testimonial evidence, credibility assessments and investigative facts and findings.

Contractors or volunteers who engage in sexual abuse will be reported to law enforcement agencies (unless the activity was clearly not criminal).

The evaluation and treatment of such victims include, as appropriate, follow-up services, treatment plans, and, when necessary, referrals for continued care following their transfer to, or placement in, other facilities, or their release from custody. Richland County Jail provides such victims with medical and mental health services consistent with the community level of care. The nurse can refer the inmate for further mental health services if required. Offender victims of sexual abuse while incarcerated are offered tests for sexually transmitted infections as medically appropriate.
